Assumption of the Risk and Waiver and Release of Liability

Relating to Coronavirus/COVID-19

Gwinnett Soccer Academy ("the Club") has put in place preventative measures to reduce the spread of COVID-19; however, the Club cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending any Club event or activity could increase your risk and your child(ren)'s risk of contracting COVID-19.

-----READ BEFORE SIGNING-----

IN CONSIDERATION OF my child/ward, _____, being allowed to participate in any way in the Gwinnett Soccer Academy related events and activities, the undersigned acknowledges, appreciates, and agrees that: The risks of injury and illness from highly communicable diseases such as COVID-19 to my child from the GSA Revolution Cup, whether occurring before, during or after participation in the event, are significant, including the potential for illness, personal injury, permanent disability and death, and while particular rules, equipment, safety precautions and personal discipline may reduce these risks, the risks of serious injury, illness and death do exist; and,

1. FOR MYSELF, SPOUSE, AND CHILD, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my child's participation in the GSA Revolution Cup; and,
2. I willingly agree to comply with the Club's stated and customary terms and conditions for participation. If I observe any unusual significant concern in my child's health and readiness for participation in the event, I will remove my child from the participation and bring such to the attention of the nearest Club official immediately; and,
3. I myself, my spouse, my child, and on behalf of my/our heirs, next of kin, personal representatives, executors, administrators, insurers and assigns, HEREBY RELEASE AND HOLD HARMLESS Gwinnett Soccer Academy; its directors, officers, employees, coaches, volunteers, officials, agents, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct any Club related events and activities ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, ILLNESS, DISABILITY, DEATH, or loss, damage, claim, actions, to person or property incident to my child's involvement or participation in these Club related events and activities and/or to the attendance or participation of me or my spouse in these Club related events and activities, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
4. I, for myself, my spouse, my child, and on behalf of my/our heirs, next of kin, personal representatives, executors, administrators, insurers and assigns, HEREBY INDEMNIFY AND HOLD HARMLESS all the above Releasees from any and all liabilities incident to my child's participation in any Club related events and/or to the attendance or participation of me or my spouse in these Club related events and activities, EVEN IF ARISING FROM THEIR NEGLIGENCE, to the fullest extent permitted by law.

I understand and agree that the terms of this Waiver and Release of Liability and Assumption of Risk apply to any COVID-19 related illness, or death to me, my spouse, or my child from the events and activities involved in these Club programs, whether occurring before, during or after participation in Club events and activities, I, FOR MYSELF, MY SPOUSE, AND CHILD/WARD, HAVE READ THIS WAIVER OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT WE HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
